We are still having large groups of women attending our meetings. Still trying to get us all on the same page concerning the jail rules and regulations. Our liaison inside the Detention Center, Gina M.- Program Coordinator, is on top of things and very supportive. I'm trying to deal with problems on my own when I can, so that I have a solution to problems when I go to Program Coordinator. We still need more volunteers. The 10-year sobriety requirement keeps our recruitment numbers very low. Working with Patti to do Outreach at meetings in our 2 counties. Meetings are every Friday: arrive at 6:15 and start A Pod at 6:45-7:30, B Pod at 7:45-8:30 unless delayed by Officer. Always out by 9PM. Better to have 2 for safety inside the Pods and walking to car in parking lot. We have only 4 volunteers. Need female volunteers.

We lost a volunteer for September and October due to a fall. Several others are unavailable due to travel and having a full life in recovery. Our newest volunteer needs one more training visit with an experienced Tavares volunteer before he can go solo. We also have one volunteer who Gina M., Program Coordinator advised will never allow to go solo but will go with more experienced volunteer. One volunteer asked to be put on backup status only in case someone is not available at last minute. Next 4 weeks we only have 4 volunteers for 2 Pods. Everyone is back in December so that should take some pressure off. Meetings are every Friday: arrive at 6:00 and start Pods: B-2A and D-2A at 6:30-7:15. Then Pods: B-2B and D-2B at 7:30-8:15 unless delayed by Officer. Always out by 8:30PM. Jim will not attempt to start going to pods on first floor until he gets more volunteers. Need male volunteers.

The 3 women volunteers had their first meeting inside on Wednesday, 27 September. We arrive 4:45: had 5 inmates Pod: CC- 5:15-6:00, 4 inmates Pod: CD- 6:10-7:00. There was ½ hour delay. Officers will help start meeting at 5PM. Delay in 2<sup>nd</sup> meeting because of COUNT. Inmates are looking forward to us returning and thanked us for Pocket Size Big Book. There are 5 volunteers with 2 having personal issues pending hoping those will be resolved within the next 2 weeks. We've set up a schedule through December with 2 of the volunteers attending October: 4 times, November: 3 times skipping Thanksgiving week, December: 2 times skipping Christmas. 2 volunteers have not gotten fingerprinted, but all have completed training. Adapted Format so we would have more time for reading Big Book and have all inmates get a chance to share. Hope 2 volunteers with personal issues will take skipped weeks and /or maybe more.
